Committee 1: Organizational Governance, Leadership, and Educational Resources

This committee is responsible for ensuring that the medical school's mission, planning, organization, and leadership are effectively guiding the institution. Selected topics include the medical education program strategic planning process, the mechanisms for faculty participation, the adequacy of bylaws and affiliation agreements, and the sufficiency of financial resources. The committee also evaluates the effectiveness of administrative leadership in supporting the educational mission through adequate resources and infrastructure.

Committee 2: Academic and Learning Environments

This committee focuses on ensuring that the learning environment is conducive to students' professional growth and development. It evaluates the policies and practices that promote diversity, non-discrimination, and professionalism within the learning environment including measures to mitigate student mistreatment.

Committee 3: Faculty Preparation, Productivity, Professional Development, and Policies

This committee oversees the preparation, productivity, and professional development of faculty. It ensures faculty are adequately prepared and supported, policies regarding faculty appointments are appropriate, and that there are sufficient faculty development opportunities to support their roles in teaching and leadership.

This committee is responsible for overseeing the structure, content, and assessment of the medical school curriculum, ensuring that it meets the competencies and objectives defined by the curriculum governance committees. The committee evaluates the curriculum to ensure it prepares students based on the Medical School Program Objectives. It reviews whether the narrative describing the curriculum is comprehensive and up-to-date and there are formal measures to continuously improve the quality of the education program based on student feedback.

This committee focuses on the processes and support systems related to student admissions and student services in the medical education program. It ensures that the admissions by-laws are clearly established and adhered to. Additionally, the Committee critically evaluates that support is sufficient for student success and well-being in areas, such as academic advising, career counseling, personal counseling, health services, and financial aid. The committee also monitors student advancement, appeal processes, and overall well-being.
